**Participant Policies and Expectations**

- 1. **Cancellations.** You are signing a contract with the Ann Arbor Ski Club and agree to adhere to the payment schedule. We will book flights, lodging, transportation and make other expenditures for you. If you cancel or are a no show, any refund will be based on what we receive back from our trip providers on your behalf and/or if your slot can be filled from a waitlist. Waitlist management is handled by the trip leader. Trips are not directly transferable by the participant. If you are sharing a room or a condo, you will still be responsible for your share of the lodging. It is possible you may lose your entire trip cost. - 2. **Behavior.** The club has a behavior policy, and all travelers are expected to abide by it. In addition, trip leaders are VOLUNTEERS and are not compensated, nor are their trips subsidized. If you have problems with travel, lodging, or other issues, they may help out, but it remains your responsibility to resolve it.
- 3. **Public Health.** The club has a Public Health policy. You agree to abide by it.
- 4. **Bedrooms.** Bed types, particularly in condos, are usually unknown until we arrive. There is no first come/first serve with respect to beds. The ski club has a procedure for determining how beds are allocated if the roommates cannot determine this among themselves.
- 5. **Ski Passes.** The **Snowmass** trip is being offered with lift tickets, which are valid at Snowmass and the other three (3) Aspen ski resorts (Aspen Mountain, Aspen Highlands, Buttermilk). YOU MAY INSTEAD, on your own, purchase an IKON pass. HOWEVER the IKON passes are quite limited this season. As of this writing, IKON "Session" and "Base" passes are NOT valid at Snowmass. The IKON "Base PLUS" pass is only good for 5 days (total at the 4 resorts) and is blacked-out the first day of our trip (Sunday Feb 17, 2024). The full blown IKON "Pass" is valid for 7 days without the blackout. The IKON passes must be purchased early in the season and are NOT transferable.
- 6. **Insurance.** The Ski club strongly recommends that participants buy trip insurance. The club will not be financially responsible for cancellations, travel delays, or other events that impact the ability to enjoy your trip. Participants acknowledge that public health-based closures and general travel chaos is a known risk of travel and accept their responsibility to financially protect themselves.

Additional Information about Payments & Costs:

- Due to various contractual issues:
  - 1- We do not expect to be able to offer single room upgrades.
  - 2- Everyone must purchase a lift ticket OR provide an IKON pass number.
- The \$2,734 price includes a 5-day (of 6) lift ticket. The following are also available:

regular	\$388	\$517	\$646

- IKON pass holders deduct \$517 (5-day regular) from the \$2,734 trip price.
- The \$150 deposit holds your spot on the trip up until the Corn Roast (08-27-23). You may cancel up until that point and receive your deposit (less \$20) back.
- The first payment is due on (or before) the Corn Roast ALONG WITH THIS SIGNED CONTRACT.
- We expect that the tour operator (Sports America in this case) will be available to collect all payments (except \$150 deposit) online either via ACH (for no fee) or credit card payment (approx. 3.5% fee).
